SCHOOL-PARENT COMPACT

The Waretown Elementary School, and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

School Responsibilities

The Waretown Elementary School will:

- Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

- **Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held in October and February and as needed/requested.
- **Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:
 - Tri-annual progress reports
 - Tri-annual report cards
- **Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as needed/requested. Staff may be contacted by parents via written correspondence, email, or phone throughout the school year. Conferences may be set up as needed.
- **Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities,** as follows:

- Parent Teacher Association activities
- Classroom observations upon parental request
